The Royal Government of Cambodia, represented by the Ministry of Economy and Finance, inked the Investment Grant Agreement on Bakheng Water Supply Project amounting of 12.7 million Euro with the European Investment Bank on 23 December 2020. The amount of this Grant Agreement will be used for eligible payment under the contracts for the three Packages of procurement of:

- The Supply and delivery of ductile iron pipes and fittings for secondary transmission main (batch2) with IPC No.: BKG-02-STM-B-PPWSA/EU including 35km of Ductile Iron Pipes and DI fittings ranging from DN 250 to 500mm.

- The Supply and delivery of Valves and Accessories (Batch 2) with IPC No.: BKG-02-AC-B-PPWSA/EU including valves, flange adaptors, dismantling joints, electromagnetic flow meters and fire hydrants ranging from 65 to 500mm.

- The Supply and delivery of HDPE Pipes & Fittings for Distribution Mains (Batch 2) with IPC No.: BKG-02-DM-B-PPWSA/EU including 862km of HDPE Pipe and fitting ranging from DN 63 to 225mm.
