1. The Kingdom of Cambodia has secured financing from the Agence Française de Développement (AFD) towards the cost of the Bakheng Water Supply Project – Phase 3. A portion of this financing will be allocated to eligible payments under Contract No.: BKG3-02-DM-B-PPWSA/AFD, which covers the supply and delivery of HDPE Pipes and fittings (Batch 2).
2. The Phnom Penh Water Supply Authority (PPWSA) (“the Purchaser”) hereby invites sealed bids from eligible bidders for the supply and delivery of HDPE pipes and fittings (Batch 2), with the following detailed requirements:

3. The office hours are from 8:00 AM to 4:30 PM (Cambodia Standard Time), Monday to Friday. The PPWSA is located at #45, Street 106, Sangkat Srah Chork, Khan Daun Penh, Phnom Penh, Kingdom of Cambodia. 4. To purchase the bidding documents, in English, bidders shall:
 - (i) A complete set of bidding documents may be purchased by interested bidders upon submitting a written application to the address indicated above. The hard copy of bidding document is available for a non-refundable fee of Two Hundred US Dollars (US\$ 200), payable in cash. If a soft copy is requested in addition to the hard copy, an additional fee of One Hundred US Dollars (US\$ 100) in cash will be charged. If a bidder requests the overseas delivery of the bidding document through a logistics provider, additional costs will be applied before sending it out in this regard.
 - (ii) Phnom Penh Water Supply Authority (PPWSA) will not be liable for any delays in delivery or loss of documents that are sent via mail or courier.
5. Bidders must submit their bid:
 - (iii) To the Phnom Penh Water Supply Authority (PPWSA) **on or before 14:30 (local time) on July 17, 2025**. The submission is made at the Hall Room, located on the 3rd floor of the New Administration Building, PPWSA, #45, Street 106, Sangkat Srah Chork, Khan Daun Penh, Phnom Penh, Kingdom of Cambodia.
 - (iv) Together with a Bid Security in the specified amount of One Hundred Thirty-Five Thousand US Dollar (US\$ 135,000).
 - (v) Bidders shall not have the option of submitting their Bids electronically.
6. The bids will be opened promptly on the submission date at the address and time indicated in item (iii) of point 5 above, in the presence of bidders' representatives who choose to attend. Late bids will be rejected.
